- The Northern Electricity Distribution Company (NEDCo), a subsidiary of the Volta River Authority (VRA) of the Republic of Ghana has allocated funds as part of its budget to cover the cost of rehabilitating its distribution network. NEDCo intends to apply part of these funds to cover eligible payments under the Contract for the Distribution Network Rehabilitation Project - Phase II in order to provide quality supply of power and to add new customers.
- 2. The Volta River Authority now invites sealed Tenders from eligible and qualified Tenderers for the detailed survey, design, manufacture, testing, supply and installation of electrical distribution materials in some selected communities in the five (5) operational areas of NEDCo.
- 3. The Works are being procured in two (2) Lots. Bidders may tender for one or both Lots and Contracts shall be awarded per Lot. However for efficient contract execution and management, as well as time constraints, no Tenderer shall be awarded both Lots. Contracts shall be awarded in a manner as to give the best economic combination to the Employer.
- 4. Tendering will be conducted through the International Competitive Tendering (ICT) procedures specified in the Public Procurement Act, 2003 and is open to all Tenderers from Eligible Source Countries as defined in the Guidelines.
- 5. Interested eligible Tenderers may obtain further information and inspect the Tendering Documents from the Volta River Authority at the address (1) given below during office hours **09.00** to **15.00 hrs GMT** each working day.
- 6. A complete set of Tendering Documents in English Language may be purchased by interested Tenderers on the submission of a written Application to the address (1) below and upon payment of a non-refundable fee of Five Hundred Ghana Cedis (Ghc500) or Six Hundred Ghana Cedis (Ghc600) including courier charges. The method of payment will be by cash or certified cheque in the name of Volta River Authority.
