To be eligible for the award of contract, tenderers shall provide satisfactory evidence to the Employer of their eligibility and of their capability and adequacy of resources to carry out the contract effectively. The tenderers shall meet the minimum criteria including particular experience and past performance in the execution of at least two similar projects in the last ten (10) years and satisfactory financial standing based on audited financial statements within the last five (5) years.
