

# SPECIFIC PROCUREMENT VOLTA RIVER AUTHORITY INVITATION TO TENDER

1. The Volta River Authority of the Republic of Ghana intends to apply part of its budgetary allocation to fund eligible payments under the Contract for the **Construction of Cable Trench at the Akosombo Generation Station in the Eastern Region.**

The Works comprises construction of cable trenches, steel supporting structures including cable trays and supply and installation of electromechanical parts complete with associated ancillary works.

2. The Volta River Authority invites sealed tenders from eligible Contractors who have registered with the Ministry of Water Resources, Works and Housing and with a financial classification certificate of **D1** and **K1**
3. The estimated period for the completion of the project is **Nine (9) months.**
4. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Act, 2003 and in the Guidelines of the Public Procurement Authority of the Republic of Ghana.
5. Interested eligible Tenderers may obtain the Tendering Document and further information from the address below from 09:00 to 15:00 hours GMT each working day from **August 25 to September 26, 2014.**
6. A complete set of Tender documents in English may be purchased at the office of the address stated below for a non-refundable fee of Five Hundred Ghana Cedis (GH¢500.00) in cash or certified cheque in the name of Volta River Authority. Tender Documents shall be available from **August 25 to September 26, 2014.**
7. Tenders shall be completed, sealed and marked **“TENDER – CONSTRUCTION OF CABLE TRENCH AT THE AKOSOMBO GENERATION STATION”** and delivered to the Engineering Services Department Conference Room, VRA – Akuse, in the Eastern Region on **September 26, 2014** by 13:00hours GMT. Tenders shall be valid up to **180 days** after the deadline of Tender submission (i.e. March 25, 2015). All Tenders must be accompanied by a Tender Security of **Fifty Thousand Ghana Cedis (GH¢50,000.00)**. The Tender Security shall remain valid for **28 days** after the end of the validity Period of the tender (i.e. April 22, 2015).
8. A mandatory site visit shall be held on **September 10, 2014** for all interested Tenderers. Tenderers are therefore required to meet at the Conference Room of the Engineering Services Department, Volta River Authority at Akuse in the Eastern Region at 11:00am for a pre-site visit meeting. **The tender of any tenderer who fails to attend the mandatory site visit shall be rejected.**
9. Tenders will be opened in the presence of representatives of Tenderers who choose to attend at the Engineering Services Department Conference Room, VRA - Akuse in the Eastern Region immediately after 13:00hours GMT on **September 26, 2014.**

**Late submissions will be rejected.**
