#### ELECTRO-VOLTA HOUSE REHABILITATION PROJECT-REPLACEMENT OF THE EXISTING WATER AND SEWAGE PIPING SYSTEM SUB-COMPONENT

- The Volta River Authority (VRA)/Electricity Company of Ghana has allocated funds as part of their budgets to cover the cost of replacing the existing water and sewage piping system at the Electro-Volta House Building and intends to apply part of these funds to cover eligible payments under the Contract for the Electro-Volta House Rehabilitation Project- Replacement of the Existing Water and Sewage Piping System Sub-component.
- 2. The Volta River Authority/Electricity Company of Ghana now invites sealed Tenders from eligible and qualified Tenderers for the decommissioning, transportation to VRA/ECG Warehouse at Accra or disposal of same (to be agreed upon) of existing water and sewage piping system at the Electro-Volta House and the replacement of same, the construction of two water harvesting systems and the separation of the bus-riser from the piping system.
- 3. Tendering will be conducted through the International Competitive Tendering (ICT) procedures specified in the Public Procurement Act, 2003 and is open to all eligible Tenderers as defined in the Procurement Guidelines.
- 4. The delivery period shall be six (6) months.
- 5. To be eligible for the award of contract, tenderers shall provide satisfactory evidence to the Employer of their eligibility and of their capability and adequacy of resources to carry out the contract effectively. The tenderers shall meet the minimum criteria including particular experience and past performance in the execution of at least two similar project in the last five (5) years and satisfactory financial standing based on audited financial statements within the last five (5) years.
- 6. Interested eligible Tenderers may obtain further information and inspect the Tender Documents from the Volta River Authority at the address (1) given below during office hours 08:30 to 15.00 hrs GMT each working day.
- 7. A complete set of Tender Documents in English Language may be purchased by interested Tenderers on submission of a written Application to the address (1) below and upon payment of a nonrefundable fee of Two Hundred Ghana Cedis (GHC200) or Four Hundred Ghana Cedis (GHC400) including courier charges. The method of payment will be by cash or certified cheque in the name of Volta River Authority.
