1. Volta River Authority (VRA) of the Republic of Ghana intends to apply part of its budgetary allocation to fund eligible payments under the Contract for Rehabilitation of Akosombo Outfall Drain.

The Works comprises the supply and placement of boulders, earthworks, concrete works, pipe work and other associated ancillary works.

2. The Volta River Authority invites sealed tenders from eligible Contractors who have registered with the Ministry of Works and Housing and with a minimum financial classification certificate of K2 and can demonstrate experience of having executed similar projects.

The total estimated period for the completion of the project is **Ten (10) calendar Months**.

3. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Act, 2003 (Act 663) and the Public Procurement (Amendment) Act, 2016 (Act 914) and is open to all tenderers as defined in the Guidelines of the Public Procurement Authority of the Republic of Ghana.

Tender Documents shall be available from **March 26, 2018 to April 19, 2018**.
6. Tenders shall be completed, sealed and marked **“REHABILITATION OF AKOSOMBO OUTFALL DRAIN”**, addressed to the Chief Executive, Volta River Authority, P. O. Box MB 77, Accra, Ghana and **delivered at the Engineering Services Department’s Conference Room, VRA – Akuse, in the Eastern Region on April 19, 2018** by 13:00hours GMT.
7. Tenders shall be valid up to **180 days** after the deadline of Tender submission. All tenders must be accompanied by a tender security of **Twenty Thousand Ghana Cedis (GHS20,000.00)**. The tender security shall remain valid for **28 days** after the validity of Tenders.
8. A **mandatory** site visit shall be held on **April 05, 2018** for all interested Tenderers. Tenderers are therefore required to meet at the office of the AMC Manager, Akosombo in the Eastern Region at 11:00am for the pre-tender meeting and site visit. **The tender of any tenderer who fails to attend the mandatory site visit shall be rejected.**
9. Tenders will be opened in the presence of representatives of Tenderers who choose to attend at the Engineering Services Department’s Conference Room, VRA - Akuse in the Eastern Region immediately after 13:00hours GMT on **April 19, 2018**.
