CONSULTANCY SERVICES FOR FIXED ASSETS PHYSICAL REVALUATION

The Volta River Authority (VRA) intends to apply part of its Internally Generated Funds (**IGF**) to make payments under the contract for Consultancy Services for a Fixed Assets Physical Revaluation of its assets in accordance with International Accounting Standards (IAS) 16. The key objectives of the Physical Revaluation study are to value the Fixed Assets and compute depreciation on current replacement cost basis for the purpose of tariff proposals and derive the covenanted rate of return on average revalued fixed assets for reporting.

The scope of services includes but not limited to the following:

 i. Value the Fixed Assets of VRA (including NEDCo) as at December 31, 2021. The Assets include Hydro and Thermal Generating Plants, Civil Works, Marine Assets and Land & Building,

ii. Review the indexation methodology and the set-up of Fixed Assets System

iii. Conduct impairment assessment of VRA's Fixed Assets in line with IAS 16.

iii. Review the accounting issues relating to International Financial Reporting Standards, which may affect Fixed Assets revaluation in Public Utilities

iv. Upload the outcome of the revaluation exercise in the Financial Application (Oracle Financials) of the VRA to update the asset values, accumulated depreciation and capital reserves for reporting purposes.

A. The VRA now invites eligible Consultants/Firms to indicate their interest in providing the service.

B. Interested Consultants/Firms must provide Expression of Interest (EOI) for the service with the following mandatory requirements and other additional information listed below:

- Valid Business Registration and Incorporation Certificates.
- Valid Tax Clearance Certificate.
- Valid SSNIT Clearance Certificate.
- Registration with the Public Procurement Authority as a Service Provider.

1. Selection/shortlisting of Consultants will be in accordance with the Mandatory Requirements, Additional Requirements (where applicable) and guided by the requirements of the Public Procurement Act 2003, (Act 663) as amended, of the Republic of Ghana.

3. A Submission Form must be signed at the time an EOI is submitted by a Representative of the Company or Organization. Only shortlisted Firms will be invited for the second stage of the procurement process (Request for Proposal) leading to a final selection of the successful Firm.
